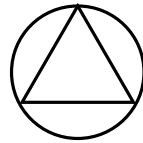

It All Begins With Prayer

I met my sponsor at the first meeting I attended when I moved to Daytona. He reminded me of my first sponsor where I sobered up two years earlier. **Gerry** was from New York, just like my first sponsor, and when I heard him share, I asked him to sponsor me. **He was wise, spoke how I felt, and he had what I wanted.** He encouraged me to share my story, and although it would be the first time I'd share my story, I reluctantly agreed. **He sat in front of me** as I stumbled through it from the podium. Afterward, he said that everyone has three stories; one we planned to tell, one we told, and one we wished we had told. How true!

I did my fifth step with him and I knew that I had chosen wisely because we were so much alike. We attended an International AA Convention with our wives. He reached out to almost everyone we passed, and **he truly enjoyed the AA way of life.** After the convention, we rented a van and drove along the Pacific coast Highway to San Francisco. We went to a baseball game (he loved baseball) and hung out in the city for a few days before returning home. **He was like a father to me.**

Whenever I was struggling, he would say, **"How's your prayer life?"** He was a devout Catholic and I would sometimes go to mass with him. Afterward, we'd go to lunch and talk program. Gerry started a few meetings in Daytona and had me Chair one in particular that appealed to me. We read out of "As Bill Sees It", focusing on one topic, reading about it, then sharing our experience, strength and hope. He had a way of **encouraging me to grow and to help the new guy** coming in the door (just like my old sponsor did).

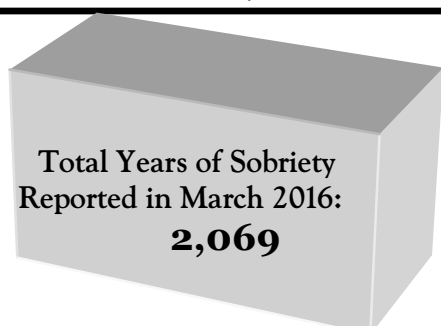
He would often begin his sharing with the phrase, "Down in the old South Bronx." Many in AA around here knew him because he had certain sayings that have stuck with us: "Time takes time"; "Good sponsorship is so important"; "It's a cinch by the inch, hard by the yard"; "The resolution of the muscles overcomes the defeatism of the mind." His version of, "Faith without works is dead." My favorite was, **"It all begins with prayer."**

I'm going to miss Gerry. He passed away late last year but **his truth and guidance will always be with me.** I loved him and will honor his memory by passing on what he so freely gave me. His last words to me were, "Pray for me." **So it all begins, and ends, with prayer.** Here's praying for you **Gerry.**

FROM THE ARCHIVES

We have recently received records from District 32 and District 8 for digitalization and storage. We have a large collection of records from individual groups as well as copies of minutes and reports from the other districts. **One of the primary tasks of the Archives is preservation.** The enemy of any collection of books, pictures and documents are the most dramatic of threats such as fire, flood, hurricanes and tornadoes. However, there are other less spectacular dangers to these items. Dampness, mold, insects and robbery should be considered hazards when storage is planned. Also, the acid in the content of the paper itself acts as an additional agent to destroy the paper over a period of time.

Making copies of the material by scanning and storing in the cloud (on the internet) is the most current method of preserving records for future historians and archivists. Retrieval of individual documents from the cloud can be an involved process but worth the effort, knowing the record is protected from any number of hazards leading to its destruction. All original materials are stored in the Intergroup archives room which is an air-conditioned and a humidity controlled environment. There is no plan to destroy any records after scanning. The cloud storage is an additional safe guard for the preservation of the collection.

Here are some guidelines to decide if a document should be preserved:

1. Could this item be a historical document in the future?
2. Will future archivist find this piece of paper valuable to the history of Alcoholics Anonymous in Volusia County?
3. Is the information on this paper up-to-date?
4. Would it be hard to get another copy of this document if it should be needed again?

If the answer is “**YES**” to all the questions - **keep the document.**

If the answers are “**NO**”- *think about tossing it.*

Where are your records stored?

February 2016 Committees, Coordinators, & Intergroup Updates

Intergroup is transferring old office transaction records into the archives. Two people have volunteered to do oldtimer interviews but *we still have no volunteer for program manager.* An Archives workshop was scheduled in Winter Park on February 20th.

Phone Army: There were 2 calls reported for January 2016.

THE TWELVE STEPS AND THE TWELVE TRADITIONS

Step Three

“Made a decision to turn our will and our lives over to the care of God as we understood Him.”

In Order for a Reason?

“Then it is explained that other Steps of the A.A. program can be practiced *with success only* when Step Three is given a determined and persistent trial.” “But now it appears that there are certain things which **only the individual can do**. All by himself, and in the light of his own circumstances, **he needs to develop the quality of willingness**. When he acquires willingness, *he is the only one* who can make the decision to exert himself. Trying to do this is an act of his own will. All of the Twelve Steps require sustained and personal exertion to conform to their principles and so, **we trust**, to God’s will.”

Tradition Three

“The only requirement for A.A. membership is a desire to stop drinking.”

TRADITIONS CHECKLIST from the A.A. Grapevine. These questions were originally published in the A.A. Grapevine in conjunction with a series on the Twelve Traditions that began in November 1969 and ran through September 1971. While they were originally intended primarily for individual use, many A.A. groups have since used them as a basis for wider discussion.

Practice These Principles...

1. In my mind, **do I** prejudge some new A.A. members as losers?
2. Is there some kind of alcoholic **whom I** privately do not want in my A.A. group?
3. **Do I** set myself up as a judge of whether a newcomer is sincere or phony?
4. **Do I** let language, religion (or lack of it), race, education, age, or other such things interfere with my carrying the message?
5. **Am I** over impressed by a celebrity? By a doctor, a clergyman, an ex-convict? Or can I just treat this new member simply and naturally as one more sick human, like the rest of us?
6. When someone turns up at A.A. needing information or help (even if he can’t ask for it aloud), **does it really matter to me** what he does for a living? Where he lives? What his domestic arrangements are? Whether he had been to A.A. before? What his other problems are?

When I Act in Accord with My Conscience I Am at Peace

Would you agree that, "Almost everywhere we turn, trust is on the decline." According to Stephen M. R. Covey in an article written for *Leadership Now*, trust is significantly lower now than it was a generation ago. Thus, after reading the In Remembrance story to Gerry on the cover of this month's issue, effective leadership and mutual trust instantly came to mind. It appeared that our friend and fellow Gerry had the qualities of character that resulted in relationships based on mutual trust.

During the February 2016 Intergroup meeting, your Intergroup Representatives discussed the fact that the Intergroup Office has been operating at a loss for quite some time. At a glance, the Profit & Loss report shows that from October 2015 – January 2016, Intergroup's **expenses** exceeded income by **\$3,286.85**. Consequently, if Intergroup continues to experience financial losses, the Intergroup Office will cease to function and Volusia County's still sick and suffering alcoholics and sober alcoholics will lose a valuable resource for recovery in our area.

Concept III affords our "trusted servants" the traditional 'Right of Decision' and outlines that the Fellowship must have trust in its "trusted servants." Which leads me to the question, "Are our trusted servants being supported in a way that will ensure that our Intergroup Office continues to grow and serve the alcoholic community?" Each A.A. problem has a solution, and it is only through the collective ideas and actions of trusted leaders, that the right A.A. solution will come to fruition.

Each month, Intergroup Coordinators, Representatives, and Steering Committee members meet to provide a valuable service to our Fellowship. They ask for experience, strength and hope for effective problem resolution. "Do you believe that the representation at service committee meetings is a true representation of A.A. in Volusia County?" My first sponsor suggested that, "With awareness comes responsibility." "Our entire A.A. program rests squarely upon the principle of mutual trust. We trust God, we trust A.A., and we trust each other." I place my trust in us.
